Mr. Anthony Ogbuokiri did a presentation regarding the purchase of the seven days week liquor license, from 214 W. Mulberry Street with the anticipation of transferring it to another address. The idea is to have a Jazz Lounge, called Panache, located at 1213 Edmondson avenue:

- 1. The operating hours are to be from 6:00 p.m.-1:00 a.m. six days a week.
- 2. The business is to be located in a residential neighborhood that has a portion of it zoned as a business district.

- 1. This used to be a Cut Rate Liquor Store back in the 90"s, then became a fragrance and Spice store selling incense. The building has been vacant for more than 3 years, and different people have been living in the building.
- 2. This building would be occupied for business Wed/Thus./Friday 5P.m. until 11:00 p.m. At this location wine/beer and food would be served. Patrons would have to sit down, consume the food and the wine and beer if so desired, but not the wine and beer without the food.

#### B-1 Zoning is what they are looking for

The real issue is: The gentleman is purchasing the liquor license that he wants to transfer from the person at 214 W. Mulberry Street. The person does not want to sell his building on Mulberry Street, because he feels that eventually the city will come through and pay a big price for the property in that area. Also please note the license that is being sold will expire May, 2014, so therefore Anthony has made a down payment on the license, now has to a building to apply it too. Anthony also explained that he is going to settlement on 1213 Edmondson Ave, the end of September. The seller is selling as residential, but the building is really zoned as commercial. Anthony and some fraternity Brothers have embarked on this endeavor.

The recommendation is to come the meeting Thursday Oct. 3, 2013-600 N. Carey St., Baltimore, MD 21217-6:00 p.m. to 7:30 p.m. and make a presentation, explaining what they want to do. What do they think they will bring to this area, that we only have two liquor licenses in this residential/commercial area? Anthony has to meet with the community, before he can be scheduled on the docket for a liquor board hearing.

An upscale jazz club would probably work because historically the area was known for jazz with the likes of Duke Elllington, Cab Calloway, Lionel Hampton, Billie Holliday and many other artists. Again Mr. Ogbuokiri would have to contact the Pennsylvania Avenue Revitalization Committee and work with that group, to see his efforts succeed.

We are not dense in West Baltimore. If the Liquor Board approves this transfer/amendment we will know who you work for. We in Harlem Park know the cost of this liquor establishments and we are not willing to pay the price.



Good day Ma'am,

I am writing with reference to the liquor license transfer for 1212 edmondson avenue from Alexander Martick.

I did not receive any notices of this most recent hearing. I did not receive notice of the hearing prior either.

My understanding is the license had been approved for transfer per the last hearing months ago wherein I was present. It was agreed that I would finish renovating the property then begin using the license. I am in the finishing stretches of renovating the property. I was advised by my counsel, Mr. Melvin Kodenski about a month ago to contact you. When I called you did not mention a hearing, you asked how much time I would require before I could start using the license. I advised that I was finishing up renovation and would need about 2 months. Again, at this conversation I was still unaware of any hearing where potentially the license transfer could be cancelled.

As a Baltimore city property owner and tax paying citizen of the state of Maryland I am simply asking that the liquor board uphold its initial finding, at the hearing where I was present, to honor the license transfer as granted at that hearing. I have worked two jobs, spent long hours away from family, exhausted my retirement fund, worked long hours on a property in a rough neighborhood for the past two years. I have personally worked, with my own two hands, alongside my contractors, to restore a neglected property in a blighted neighborhood, an endeavor that few have the courage, or tenacity to



undertake. I have endured property vandalization and physical threats to my person in my efforts to renovate this property. I have paid over \$11000 for the license, have made the monthly payments every month, and have spent over \$40000 in building acquisition and renovation costs. It is unimaginable for me that all of this would be in vain. The equitable outcome is to allow me to finish my struggle to renovate the property and let me open for business.

I conclude on a personal note. Opening this bar has been the only dream I allowed myself to have. I used the word "allowed" for a reason; my fear of how dreams can be scuttled. My dream, with all good fruits it could have borne, should not end simply because I have been working hard to bring it into reality. I have bought the building, I have been paying for the license. I can only pray the liquor board allows a new economically viable entity to come into existence in a neighborhood that is in dire need of such instead of using it's authority to questionably terminate my dream.
